## **30-DAY NOTICE OF CONSTRUCTION WORK** **Traffic Railing Replacement at Richland Avenue Bridge** **Contract No. 1832J**

Gordon N. Ball, Inc. is under contract with San Francisco Public Works to complete the work on the Traffic Railing Replacement at Richland Avenue Bridge. This contract will include bridge railing demolition and replacement as well as structural patching of the substructure. Public Works will manage the project during construction. A more detailed notice will be sent to fronting properties on Richland Avenue, Arlington Street or Miguel Street about 10 days before the works is scheduled to begin.

### **CONSTRUCTION SCHEDULE**

Construction is scheduled to **begin in March 2021** and be completed in November 2021. It may be weeks before we begin construction on your block. “No Parking/Tow Away” signs (as necessary) will be posted 72 hours in advanced with the specific work dates, hours and parking restrictions on your block.

Saturday and Sunday: 7:00 AM – 6:00 PM (as necessary)  
Saturday through Sunday: 12:00 AM – 12:00 PM (as necessary)  
Monday: 12:00 AM – 5:00 AM (as necessary)

### **PROJECT LOCATION**

Richland Avenue Bridge between Arlington Street and Mission Street above San Jose Avenue.

### **Traffic Impact**

The Richland Avenue Bridge will be fully closed for several months during this work, at which time no local traffic will be permitted on the Bridge. Stretches of San Jose Avenue approaching the underside of the Richland Avenue Bridge will also be subject to lane closures. Areas on San Jose Avenue near Dolores Street, Randall Street, Brook Street, Rousseau Street, Milton Street and St. Mary’s Avenue will also be affected at times by traffic control measures. “NO PARKING/TOW AWAY” signs will be posted 72 hours in advance to alert the public of the construction of and parking restrictions. **Cars parked in the areas posted as “No Parking” will be towed at the vehicle owner’s expense.**

Access to driveways and sidewalks will be maintained at all times. Please observe parking and traffic signage and allow extra travel times during construction.
