## Third Street Bridge Rehabilitation Project Upcoming Night Work Notification

Dear Residence / Business Owner,

In addition to the ongoing Day Shift of work, American Bridge Company will begin a Night Shift as part of the **Third Street Bridge Rehabilitation Project** (Contract Number 1000007012) to facilitate the remaining construction activities of Third Street Bridge, "Lefty O'Doul Bridge", located just south of Oracle Park on Third Street.

This Night Shift work is scheduled to begin on **Monday, October 14, 2019** and night work is anticipated to continue intermittently from 8PM to 7AM through **Friday January 31, 2020**. Shifts may vary from five days per week to seven days per week depending on the work activities being performed

The work to be performed during the night phase includes, but is not limited to, the following:

- Installation of new structural steel
- Installation of new pedestrian walkways
- Installation and removal of temporary scaffolding
- Blasting and painting of structural steel
- Bolting and welding of steel components
- Installation of certain new electrical items
- Installation of certain new mechanical items

Every effort will be made by the contractor to minimize construction related noise impacts during the nighttime work, but please note that general construction related noise from the use of heavy equipment such as forklifts, generators, drills, and small tools is to be expected.
