30-DAY NOTICE OF CONSTRUCTION

- Project Name:** **Upper Market Corridor Safety Improvements Project**
Contract ID NO. 1000017336
- Description of Work:** San Francisco Public Works will soon begin safety and infrastructure improvements as part of the **Upper Market Corridor Safety Improvements Project on Market Street between Castro Street and Octavia Blvd.** Construction is anticipated to be completed in two segments, with work focused first on the segment of Market Street between **Octavia Blvd. and 14th Street**, followed by work between **14th Street and Castro Street**.
- The scope of work for this project will include sewer work (on some blocks), ADA curb ramp reconstruction, electrical traffic signal work, median island lighting work, landscaping, streetscape improvements, concrete road base repair, and roadway grinding and paving restoration.
- Construction Schedule:** **Octavia Blvd. to 14th Street: July 2021 through November 2021***
14th Street to Castro Street: January 2022 through July 2022*
(Due to the length of the project limits and sequencing of construction activity, it may be weeks or months before construction activity begins in your area. Crews may return multiple times to a specific location to complete additional scope of work.)
- Work Hours:** Monday through Friday, **7:00 AM – 3:00 PM***
(*Anticipated construction schedules and work hours may vary and are subject to change. Work on Saturday/Sunday or night work after hours (8 PM-7 AM) is permitted and possible, depending on the scope of work, but has not been scheduled or confirmed at this time.)
- Pedestrian, bicycle and vehicle traffic may be temporarily impacted or rerouted as a result of intersection and lane closures necessary to perform the work. Please check any **“No Parking / Tow Away”** signs posted on the block for exact work hours and locations because they may vary depending on the construction task. **No Parking Signs** will be posted at least **72 hours** in advance of work to alert motorists of parking restrictions. **Residents along the immediate project limits will receive a follow-up notice about 10 days prior to the start of construction activity in their segment.**
